Consumer Confidence Report of Water Quality City of Okoboji, Iowa

We're pleased to present to you this year's Annual Water Quality Report. This report is designed to inform you about the quality water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water. We're pleased to report that our drinking water is safe and meets federal and state requirements. They are held on the 2nd Tuesday of every month at Central Water System 3300 Lake Shore Drive, Okoboji, Iowa 51355 at 4:30 p.m. Central Water Systems routinely monitors for contaminants in your drinking water according to Federal and State laws. Central Water System obtains its water from West Lake Okoboji. West Lake Okoboji was determined to be highly susceptible to contamination because it is a surface water supply. The West Lake Okoboji water source will be most susceptible to activities such as underground storage tanks, landfills, hazardous waste sites, permitted National Pollutant Discharge Elimination System sites and land use patterns (urban and agricultural). The Howard R. Green Company has completed a detailed evaluation of our source water supply. It is available at the main office of Central Water System. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and

young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Okoboji is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. The test results for the City of Okoboji on the following page shows the results of our monitoring for the period of January 1 – December 31, 2016. In this table you will find many terms and abbreviations with which you may not be familiar. To help you better understand these terms, we've provided the following definitions:

Parts per million (ppm) or milligrams per liter (mg/l) – one part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or micrograms per liter – one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

Picocuries per liter (pCi/L) – picocuries per liter is a measure of the radioactivity in water.

Millirems per year (mrem/yr) – measure of radiation absorbed by the body.

Nephelometric Turbidity Unity (NTU) – nephelometric turbidity unit is a measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable by sight of the average person.

Treatment Technique (TT) – A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.

Maximum Contaminant Level Goal – The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Action Level (AL) – The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Non-Detects (ND) – Laboratory analysis indicated that the constituent is not present.

Maximum Residual Disinfectant Level Goal (MRDLG) – The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Maximum Residual Disinfectant Level (MRDL) – The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants. RAA – Running Annual Average

We're proud that your drinking water meets or exceeds 911 Federal and State requirements. The EPA has determined your water IS SAFE at these levels. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. More information about the contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline at 1-800-426-4791. MCL's are set at very stringent levels. To understand the possible health effects described for many regulated contaminants, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

Thank you for allowing us to continue proving your family with clean, quality water this year. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers.
