MINUTES OF THE OKOBOJI CITY COUNCIL MEETING HELD FEBRUARY 13, 2018

Mayor Mary VanderWoude called the meeting to order at 6:00 pm on February 13, 2018. All those present stood and recited the Pledge of Allegiance. Councilmembers Jim Delperdang, Julie Andres, Jerry Robinson, and Walter Mendenhall, via telephone, were all present for Roll Call. Councilmember Jim Hentges joined the Council late. Others present were City Administrator Michael Meyers, Deputy City Clerk Amanda Harskamp, Police Chief Jason Petersen, and Water Superintendent Neal Houge. PUBLIC HEARING – AMENDMENT TO CHAPTER 92

The City Council conducted a public hearing to consider proposed Ordinance No. 239 an amendment to Chapter 92 – Water Rate Ordinance of the City of Okoboji Municipal Code. There were no comments or written comments in favor or against the proposed Ordinance.

Mayor VanderWoude introduced and discussed the first reading of the proposed Ordinance No. 239 an Ordinance replaced language of Chapter 92 with new language. Mayor VanderWoude advised that to the Council that the proposed Ordinance was in response to a recent rate increase by Central Water System. The rate increase by Central Water System will then pass through to the City. Motion made by Councilmember Hentges and a second by Councilmember Andres to appoint Ms. Shuttleworth and Mr. Robinson to act representative and alternate representative for the Watershed Management Authority. The following Councilmembers voted "YEA": Delperdang, Andres, Robinson, Hentges, and Mendenhall. The following Councilmembers voted "NAY": None. Motion passed 5-0.

Mayor VanderWoude presented for review Mr. Don Nolan's dock permit. Motion made by Councilmember Robinson and a second by Councilmember Hentges to approve Mr. Don Nolan's six-spot dock permit. The following Councilmembers voted "YEA": Delperdang, Andres, Robinson, Hentges, and Mendenhall. The following Councilmembers voted "NAY": None. Motion passed 5-0.

Mayor VanderWoude presented and discussed the budget for the City Fiscal Year 2018/2019 and to set a date for a Public Hearing. Mayor VanderWoude advised the City Council that the City's Finance Committee met previously to discuss the next Fiscal Year's Budget. It was the recommendation of the Finance Committee to raise the City of Okoboji's levy rate from 4.50 to 4.75. Motion made by Councilmember Hentges and a second by Councilmember Robinson to set the public hearing date for March 13th, 2018 for the budget for the City Fiscal Year 2018/2019. The following Councilmembers voted "YEA": Delperdang, Andres, Robinson, Hentges, and Mendenhall. The following Councilmembers voted "NAY": None. Motion passed 5-0.

Mayor VanderWoude presented and discussed the Board of Adjustment's recommendation to grant a variance to McDonald's Corporation, owner of 1004 Stakeout Road, for their signage. A motion made by Councilmember Andres and a second by Councilmember Hentges to approve the signage variance as recommended by the Board of Adjustment. The following Councilmembers voted "YEA": Delperdang, Andres, Robinson, Hentges, and Mendenhall. The following Councilmembers voted "NAY": None. Motion passed 5-0.

Mayor VanderWoude tabled the agenda item relating to hearing and considered the final bargaining proposal from Teamsters 554 representing the Okoboji Police Officers.

At 6:33 pm a motion was made by Councilmember Hentges and Councilmember Robinson to enter into exempt session to discussion bargaining proposals from Teamsters 554 representing the Okoboji Police Officers. The following Councilmembers voted "YEA": Delperdang, Andres, Robinson, Hentges, and Mendenhall. The following Councilmembers voted "NAY": None. Motion passed 5-0.

At 6:45 pm the Council voted out of exempt session and entered back into an open session.

Mayor VanderWoude presented and discussed proposed settlement agreement with the Okoboji Commons Hotel and discussed pending litigation. City Attorney Dave Stein discussed the stipulation and settlement agreement with the Council. A motion made by Councilmember Andres and a second by Councilmember Robinson to authorize the City Attorney to enter into a stipulation and settlement agreement and to authorize Mayor VanderWoude and Deputy City Clerk Harskamp to sign off on said agreement. The following Councilmembers voted "YEA": Delperdang, Andres, Robinson, Hentges, and Mendenhall. The following Councilmembers voted "NAY": None. Motion passed 5-0.
