

ORDINANCE NO. 243

ORDINANCE AMENDING THE CODE OF ORDINANCE OF THE CITY OF OKOBOJI, IOWA, BY ADDING NEW LANGUAGE IN SECTION 63.04 "SPECIAL SPEED ZONES" DESIGNATING STAKEOUT ROAD FROM THE INTERSECTION OF HIGHWAY 71 TO THE INTERSECTION OF CHALTROMS BEACH ROAD TO HAVE A 25 MPH SPEED LIMIT".

WHEREAS, the Council ("Council") of the City of Okoboji, Dickinson County, Iowa ("City") is considering an amendment to the "Special Speed Zones" ordinance;

WHEREAS, the City is considering adding new language to now require Stakeout Road have a 25 MPH speed limit between the intersections of Highway 71 and Chaltroms Beach Road;

BE IT ENACTED by the City Council of the City of Okoboji, Iowa:

SECTION 1. The Code of Ordinances of the City of Okoboji, Iowa, Section 63.04 under subsection 1 (Special 25 MPH Speed Zones) and under point A is hereby amended by adding the following:

A. Stakeout Road between the intersections of Highway 71 and Chaltroms Beach Road.

SECTION 2. REPEALER. All Ordinances or part of Ordinances in conflict with the provision of this Ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any Section, provision or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any Section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 4. PUBLICATION. The City Clerk/Administrator is hereby authorized and directed to publish this Ordinance in a newspaper of general circulation in Dickinson County, Iowa in conformance with the Iowa law.

WHEREAS, a motion was made by Councilmember Delperdang and seconded by Councilmember Robinson to consider this Ordinance and upon roll call the following vote was recorded: AYES: Delperdang, Andres, Robinson; NAYS: Hentges, Mendenhall. Said motion to consider this Ordinance was approved by the City Council;

WHEREAS, a motion was made by Councilmember Hentges and a second by Councilmember Andres to consider this on its second reading and upon roll call the following vote

was recorded: AYES: Delperdang, Hentges, Andres, Robinson, Mendenhall; NAYS: None. Said motion to consider this Ordinance on the second reading was approved by the City Council.

WHEREAS, a motion was made by Councilmember Robinson and seconded by Councilmember Hentges to waive the third considerations of this Ordinance and upon roll call the following vote was recorded: AYES: Delperdang, Hentges, Andres, Robinson, Mendenhall NAYS: None. Said motion to waive the third consideration of this Ordinance was approved by the City Council, and therefore, the third considerations of this Ordinance were waived;

WHEREAS, a motion was made by Councilmember Robinson and seconded by Hentges to adopt this Ordinance and upon roll call the following vote was recorded: AYES: Delperdang, Hentges, Andres, Robinson, Mendenhall; NAYS: None. Said motion to adopt this Ordinance was approved by the City Council. Thereupon, the Mayor declared this Ordinance, passed and approved on the date shown below;

NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Okoboji, Iowa:
