

ORDINANCE NO. 253

**AN ORDINANCE TO AMEND CHAPTER 15, MAYOR, SECTION 15.04
COMPENSATION AND CHAPTER 17, CITY COUNCIL, SECTION 17.06
COMPENSATION**

BE IT ENACTED by the City Council of the City of Okoboji, Iowa as follows:

SECTION 1: PURPOSE. The purpose of this Ordinance is to amend the Code of Ordinances for the City of Okoboji to provide for change of the Mayor and Councilmembers compensation effective January 1, 2020.

SECTION 2: AMENDMENT. Chapter 15, Section 15.04 and Chapter 17, Section 17.06, of the Code of Ordinances of the City of Okoboji, Iowa, be amended by striking Section 15.04 and inserting in lieu thereof the following:

15.04 COMPENSATION. The salary of the Mayor is forty-eight hundred (\$4,800) per year.

And also amended by striking 17.06 and inserting in lieu thereof the following:

17.06 COMPENSATION. The salary of each Council member is fifty dollars (\$50.00) for each regular and special meeting of the Council attended, and fifty dollars (\$50.00) for each outside meeting at which attendance is required, and fifty dollars (\$50.00) for each committee meeting.

SECTION 3: REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 4: SEVERABILITY CLAUSE. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION 5: EFFECTIVE DATE. This ordinance shall be effective upon its passage, approval and publication as provided by law.

SECTION 6: PUBLICATION. The City Clerk/Administrator is hereby authorized and directed to publish this Ordinance in a newspaper of general circulation in Dickinson County, Iowa in conformance with the Iowa law.

WHEREAS, a motion was made at the August 13, 2019 regular meeting after public hearing by Councilmember Hentges and seconded by Councilmember Delperdang to consider approval of this Ordinance (first consideration) and upon roll call the following vote was recorded: AYES: Delperdang, Hentges, Robinson, Mendenhall; NAYS: None. Said motion to consider approval of this Ordinance (first consideration) was approved by the City Council;

WHEREAS, a motion was made at the August 13, 2019 regular meeting by Councilmember Hentges and seconded by Councilmember Robinson to waive the second and third consideration of this Ordinance and upon roll call the following vote was recorded: AYES: Delperdang, Hentges, Robinson, Mendenhall; NAYS: None. Said motion to waive to second and third consideration of

this Ordinance was approved by the City Council, and therefore, the second and third consideration of this Ordinance were waived;

WHEREAS, a motion was made at the August 13, 2019 regular meeting by Councilmember Robinson and seconded by Councilmember Mendenhall to consider the adoption of this Ordinance (final consideration) and upon roll call the following vote was recorded: AYES: Delperdang, Hentges, Robinson, Mendenhall; NAYS: None. Said motion to adopt this Ordinance was approved by the City council. Thereupon, the Mayor declared this Ordinance, passed and approved on the date shown below.


NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Okoboji, Iowa.
