

MINUTES OF THE OKOBOJI CITY COUNCIL MEETING HELD ON FEBRUARY 2, 2021

Mayor VnaderWoude called the meeting to order at 9:00 AM on February 2, 2021. Councilmembers Delperdang, Hentges, Robinson, and Andres were present. Councilmember Mendenhall was present via Zoom conference call. Others present were City Administrator Michael Meyers, Police Chief Jason Petersen, City Attorney David Stein, Officer Brent Sexton, Officer Josh Zigrang, and Scott Utech.

NEW BUSINESS

Mayor VanderWoude opened the meeting and explained the meeting was to initiate negotiations with the City of Okoboji Police Union (Teamsters Local #554).

Motion made by Councilmember Andres and a second by Councilmember Hentges to move out of open session and go into exempt session under Iowa Code Section 20.17(3) for negotiation session with union representatives. The following Councilmembers voted AYE: Delperdang, Hentges, Andres, Mendenhall, Robinson. Motion passed 5-0.

The Council came out of exempt session and the union representatives discussed proposal to the City of Okoboji.

Motion made by Councilmember Hentges and a second by Councilmember Robinson to move out of open session and go into exempt session under Iowa Code Section 20.17(3) for negotiation session with union representatives. The following Councilmembers voted AYE: Delperdang, Hentges, Andres, Mendenhall, Robinson. Motion passed 5-0.
