

MINUTES OF THE OKOBOJI CITY COUNCIL MEETING HELD ON APRIL 27, 2021

Mayor VanderWoude called the meeting to order at 9:00AM on April 27, 2021. Councilmembers Robinson, Andres, Mendenhall, and Delperdang were present. Councilmember Hentges was excused. Others present were City Administrator Michael Meyers.

NEW BUSINESS

Mayor VanderWoude presented Resolution 21-24, “A Resolution Appointing UMB Bank, N.A of West Des Moines, Iowa to Serve as Paying Agent, Note Registrar, and Transfer Agent, Approving the Paying Agent and Note Registrar and Transfer Agent Agreement and Authorizing the Execution of the Agreement”.

Motion made by Councilmember Robinson and a second by Councilmember Mendenhall to approve Resolution 21-24. The following Councilmembers voted “AYE”: Andres, Delperdang, Mendenhall, Robinson. Motion passed 4-0.

Mayor VanderWoude presented Resolution 21-25, “A Resolution Amending the ‘Resolution Authorizing the Issuance of \$3,085,000 General Obligation Capital Loan Notes, Series 2021B, and Levying a Tax for the Payment Thereof,’ Passed and Approved on February 9, 2021, by Substituting a New Resolution Therefor, Approving and Authorizing a form of Loan Agreement and the Authorizing and Providing for the Issuance of \$3,085,000 General Obligation Capital Loan Notes, Series 2021B, and Levying a Tax to Pay Said Notes; Approval of the Tax Exemption Certificate and Continuing Disclosure Certificate”

Motion made by Councilmember Andres and a second by Councilmember Robinson to approve Resolution 21-25. The following Councilmembers voted “AYE”: Andres, Delperdang, Mendenhall, Robinson. Motion passed 4-0.

Mayor VanderWoude presented Resolution 21-26, “A Resolution Setting a Public Hearing for Review and Consideration of the First Amendment of the FY2020/2021 City Budget”

City Administrator Meyers explained this public hearing would be set Monday, May 24, 2021 at 3:30 PM.

Motion made by Councilmember Andres and a second by Councilmember Robinson to approve Resolution 21-26. The following Councilmembers voted “AYE”: Andres, Delperdang, Mendenhall, Robinson. Motion passed 4-0.

Mayor VanderWoude presented Resolution 21-27, “A Resolution to Approve a Three-Year Contract between Teamsters Local #554 and the City of Okoboji, Iowa”

Resolution 21-27 was tabled. No further action taken.
